

## OFFICIAL RULES

### ILLINOIS LOTTERY HOTWINS® DOLLAR DAYS OF SUMMER EVENT

#### NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE ODDS OF WINNING.

- PROMOTION PERIOD:** The Illinois Lottery HotWins® Dollar Days of Summer Event (“Promotion”) shall be on June 30, 2026 from 11:00 am Central Time (“CT”) to 3:00 pm CT or until all prizes are awarded, whichever occurs earlier (“Promotion Period”) at Plaza of the Americas, located at 430 North Michigan Avenue, Chicago, IL 60611 (“Promotion Location”).
- SPONSOR AND ADMINISTRATOR:** For purposes of these Official Rules, “Illinois Lottery” shall mean the Illinois Department of the Lottery, which is acting through Allwyn Illinois LLC in its capacity as private manager or its successor designated by the Illinois Lottery (“Sponsor”). The Promotion is administered by Flowers Communications Group or a successor designated by Sponsor (“Administrator”).
- AGREEMENT TO THE OFFICIAL RULES:** By participating in the Promotion, all participants fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor and Administrator as final and binding in all matters related to the Promotion. Winning a prize (described below) is contingent upon fulfilling all requirements set forth herein.
- HOW TO ENTER:** Entrants must visit the Illinois Lottery display located at the Promotion Location during the Promotion Period. Entrants will receive four (4) magnetic tokens and have the opportunity to play a game (“Game”) in which they select four (4) different numbers from numbers 1-80 on an oversized gameboard. Four (4) entrants will take their turn at the same time, and entrants can pick the same numbers if desired. After the entrants have selected their numbers, the Illinois Lottery Emcee (“Emcee”) will show a drawing where 20 winning numbers will be selected. An Illinois Lottery Brand Ambassador (“Ambassador”) will verify if any of entrant’s numbers match the winning numbers. If an entrant matches 2, 3, or 4 of their numbers to the winning numbers, they will receive a token that can be redeemed for a prize at the Promotion prize tent. If they match 0 or 1 of their numbers to the winning numbers, they will be invited to visit the draw ball machine (“Machine”).

For entrants who visit the Machine, an Ambassador will activate the Machine to dispense one numbered ball per entrant. The Ambassador will show the dispensed ball to the entrant, then give the entrant a token that can be redeemed for a prize at the Promotion prize tent. Participation is limited to one (1) Game and, if applicable, one (1) Machine visit per entrant.

The Illinois Lottery, Sponsor, and the Administrator are not responsible for entries that are incomplete or inaccurate. The Illinois Lottery, Sponsor, and Administrator assume no responsibility for lost, mutilated, late, stolen, or misdirected entries.

- ODDS:** Eligible players who participate in the Promotion will have a 100% chance of winning a prize.

**6. DRAW MANAGEMENT:** There shall be one (1) Machine at the Promotion Location. The Administrator will insert a maximum of 48 balls in the draw ball machine. The Administrator will insert 16 ball number 1s, 8 ball number 2s, 8 ball number 3s, 4 ball number 4s, and 12 ball number 5s. After any ball is dispensed, the Administrator will put such ball into a blue bucket. When the Machine only has 15 balls remaining in it, the Administrator will add the balls in the blue bucket to the Machine, until the maximum number of prizes for each ball number has been drawn, then such ball numbers will be set aside and no longer inserted into the Machine. For example, the Administrator will place ball number 1s in the blue bucket along with the other drawn balls until the ball number 1s have been disbursed a maximum of 100 times (i.e., the maximum number of prizes for ball number 1). Thereafter, as the maximum quantity of prizes for each ball number have been awarded, those balls will be removed from the rotation and no longer be placed into the Machine.

**7. ELIGIBILITY:** The Promotion is open only to individuals who, at the time of entry, are at least 18 years of age. In addition, the following persons are not eligible to enter this Promotion nor claim a prize: (a) the employees, officers, directors, partners, equity holders, members, and agents of the Sponsor or Administrator; (b) any member of the Illinois Lottery Control Board (“Board”), and any officer or any other person employed by the Board or the Illinois Lottery; (c) officers and employees of advertising, public relations, and sales promotion agencies employed by the Illinois Lottery, Sponsor, or Administrator, who are directly involved in the Illinois Lottery engagement; (d) officers and employees of audit firms performing services for the Illinois Lottery; (e) other contractors and agents of the Illinois Lottery; (f) any spouse, child, or family member residing as a member of the same household in the principal place of residence of any person designated in (a) through (e) above. This Promotion is void where prohibited by law.

**8. PRIZES AND THE VALUE OF THE PRIZES:**

*Game Prizes*

**\$150 Prizes:** Each \$150 Prize winner will receive \$150.00 (“\$150 Prize”). The approximate retail value (“ARV”) of the \$150 Prize is \$150.00.

**\$125 Prizes:** Each \$125 Prize winner will receive \$125.00 (“\$125 Prize”). The ARV of the \$125 Prize is \$125.00.

**\$110 Prizes:** Each \$110 Prize winner will receive \$110.00 (“\$110 Prize”). The ARV of the \$110 Prize is \$110.00.

The \$150 Prize, \$125 Prize, and \$110 Prize will be paid out at a total maximum of \$10,000.00.

*Machine Prizes*

**One Hundred (100) Ball 1 Prizes:** Each Ball 1 Prize winner will receive \$100.00 (“Ball 1 Prize”). The ARV of the Ball 1 Prize is \$100.00.

**Fifty (50) Ball 2 Prizes:** Each Ball 2 Prize winner will receive \$90.00 (“Ball 2 Prize”). The ARV of the Ball 2 Prize is \$90.00.

**Fifty (50) Ball 3 Prizes:** Each Ball 3 Prize winner will receive \$80.00 (“Ball 3 Prize”). The ARV of the Ball 3 Prize is \$80.00.

**Twenty-Five (25) Ball 4 Prizes:** Each Ball 4 Prize winner will receive \$70.00 (“Ball 4 Prize”). The ARV of the Ball 4 Prize is \$70.00.

**Seventy-Five (75) Ball 5 Prizes:** Each Ball 5 Prize winner will receive \$60.00 (“Ball 5 Prize”). The ARV of the Ball 5 Prize is \$60.00.

The dates and times of the Promotion may be subject to change and cancellation. The winner(s) and guest(s) agree to comply with all applicable venue rules and policies in connection with the prizes. The Event organizers have the right to remove or to deny entry to any winner or guest who engages in an unsportsmanlike or disruptive manner, or exhibits an intent to annoy, abuse, threaten, or harass any other person at the Event. Any comments made by a winner in a social media format containing material that is inappropriate, offensive, indecent, obscene, hateful, tortious, defamatory, slanderous, or libelous may disqualify the winner, at the sole discretion of Sponsor and/or Administrator, as applicable. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppage, or any other natural disaster outside their control that may cause the cancellation or postponement of the Promotion, and/or the fulfillment of any prizes. All other expenses and costs, not expressly listed above, including, but not limited to, federal, state, and local taxes, parking, and ground transportation are the winners’ sole responsibility. All travel risks, insurance, loss, or damage due to prize acceptance or use are the sole responsibility of the winner(s). The Released Parties will not be responsible for any loss, liability, or damage arising out of a winner’s acceptance or use of a prize. The prizes are not exchangeable or otherwise transferable. The Sponsor and Administrator, are not responsible if any prize is lost, stolen, destroyed, or used without permission.

**9. WINNER SELECTION AND NOTIFICATION TO PRIZE WINNERS:** All of the prize winners will be determined at the Promotion Location during the Promotion via entrants’ Game matches or, if applicable, Machine numbers. All entrants must be present to win.

For the Game, an Ambassador will give eligible entrants a token that can be redeemed at the Promotion prize tent for the prize that corresponds with the number of entrant’s matches. Eligible entrants who match 4 numbers will receive a token that can be redeemed for the \$150 Prize, subject to availability. Eligible entrants who match 3 numbers will receive a token that can be redeemed for the \$125 Prize, subject to availability. Eligible entrants who match 2 numbers will receive a token that can be redeemed for the \$110 Prize, subject to availability.

For the Machine, an Ambassador will give the entrant a token that can be redeemed at the Promotion prize tent for the prize that corresponds with the entrant’s dispensed ball number. Eligible entrants who draw a ball number 1 will receive the Ball 1 Prize, subject to availability. Eligible entrants who draw a ball number 2 will receive the Ball 2 Prize, subject to availability. Eligible entrants who draw a ball number 3 will receive the Ball 3 Prize, subject to availability. Eligible entrants who draw a ball number 4 will receive the Ball 4 Prize, subject to availability. Eligible entrants who draw ball number 5 will receive the Ball 5 Prize, subject to availability.

**10. GENERAL PRIZE RESTRICTIONS:** Prizes are subject to availability and change. No substitution or cash redemption allowed by winners. No cash equivalent of the prizes will be awarded, and the prizes are not exchangeable or otherwise transferable. The Sponsor and Administrator reserve the right to substitute the prize in whole or in part with other prizes of comparable or greater value, if the intended prize is not available for any reason, as determined by the Sponsor and Administrator, in their sole discretion. Transportation and lodging are not included. The winner(s) will be exclusively and solely responsible for travel to and the costs thereof, and all other costs and expenses associated with prize acceptance and use not described as being provided, including but not limited to parking expenses, gratuities, incidentals, and other expenses incurred by accepting a prize. This Promotion is governed by and shall be construed in accordance with Illinois law and is subject to all applicable federal, state, and local laws and regulations. Any and all taxes, including but not limited to federal, state, and local taxes, are the exclusive and sole responsibility of the winner(s). Each winner may be required to provide his or her Social Security number and appropriate tax documentation for tax reporting purposes. If required, Sponsor, Administrator, or designee will file an IRS Form 1099 or similar document with the Internal Revenue Service for the fair market value of any prize.

Prizes may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game, event, or exhibition tickets.

**11. GENERAL CONDITIONS AND RELEASE:** The Promotion is subject to applicable laws and regulations. By entering, each entrant (a) agrees to defend, indemnify, release, and hold harmless the Sponsor, Administrator, Ambassadors, and Illinois Lottery (collectively the "Promotion Entities"), and each of their respective owners, parents, affiliates, subsidiaries, directors, officers, agents, employees, managers, licensees, distributors, dealers, retailers, printers, representatives, advertising and promotion agencies, and any and all other companies associated with the Promotion, and all of their respective officers, directors, employees, agents, and representatives (collectively, the "Released Parties") from and against any and all claims, causes, costs, injuries, losses, or damages of any kind that may occur, directly or indirectly, in whole or in part, arising out of the entrant's participation in this Promotion or receipt or use of any prizes, including, but not limited to: (i) unauthorized human intervention in the Promotion; (ii) technical errors related to computers, servers, providers, or telephone or network lines; (iii) printing errors; (iv) lost, late, postage-due, misdirected, or undeliverable mail; (v) errors in the administration of the Promotion or the processing of entries, including but not limited to data entry errors resulting from or caused by the entering, keying, or mis-keying of the required information by entrants; (vi) injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use of any prize; (vii) the unauthorized or illegal access to personally identifiable or sensitive information or the acceptance, possession, use, or misuse of any prize or any travel or activity related to the receipt or use of any prize; (b) if selected as the winner, consents to the use by Illinois Lottery, Sponsor, and each of its respective designees of the winner's name, hometown, photograph, voice, or other likenesses and prize information for promotion, advertising, and marketing purposes in any media or format now known or hereafter devised, throughout the world, in perpetuity, without additional compensation, consideration, notification, or permission, unless prohibited by law, and upon request will provide written confirmation of such consent; and (c) acknowledges that relative to any prize including, but not limited to, its quality or availability, none of the Released Parties or anyone else has either

made, or is in any manner responsible or liable for, any warranty, representation, or guarantee, either expressed or implied, in fact or in law, related to any prize including but not limited to, its quality and availability and ALL SUCH WARRANTIES ARE DISCLAIMED IN THEIR ENTIRETY.

None of the Released Parties nor any of their service providers are responsible for incorrect or inaccurate transcription of entry information; any human or other error, technical malfunctions; lost or delayed data or voice transmission; omission; interruption; deletion; defect; line failures of any telephone network, computer equipment, or software; inability to access any online service or website or to complete a telephone call or facsimile transaction; any other error or malfunction; late, lost, or misdirected mail; or any injury or damage to an entrant's or any other person's computer related to or resulting from participation in this Promotion.

None of the Released Parties are responsible for or liable for: (a) late, lost, damaged, misdirected, misaddressed, incomplete, unintelligible, illegible or postage due entries; (b) telephone, electronic, hardware or software program, network, internet or computer malfunctions, failures or difficulties of any kind; (c) failed, incomplete, garbled, or delayed computer transmissions; (d) any condition caused by events beyond the control of Sponsor that may cause the Promotion to be disrupted or corrupted; (e) any injuries, losses, or damages of any kind arising in connection with or as a result of the Promotion, acceptance, possession, or from participation in the Promotion; (f) any printing or typographical error in any material associated with the Promotion; (g) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, wireless service, mail, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties that may occur in connection with the administration of the Promotion, the processing of entries, the announcement of the prizes, or in any Promotion-related materials; or (h) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Promotion.

Sponsor and Administrator reserve the right, in their sole discretion, to cancel the Promotion in its entirety, if it becomes technically corrupted or because of non-authorized human intervention. If any discrepancy should exist between these Official Rules and any promotional material describing this Promotion, these Official Rules shall govern.

**CAUTION:** ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DAMAGE ANY WEBSITE ASSOCIATED WITH THIS PROMOTION, TAMPER WITH THE ENTRY PROCESS, OR OTHERWISE UNDERMINE THE CONTENT OR LEGITIMATE OPERATION OF THE PROMOTION MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR WILL DISQUALIFY ANY SUCH ENTRANT, AND SPONSOR AND THE APPLICABLE PROMOTION ENTITIES AND THEIR RESPECTIVE AGENTS RESERVE THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH ENTRANT OR INDIVIDUAL(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.

No failure to enforce any term of these Official Rules shall constitute a waiver of that provision. These Official Rules may be modified for clarification purposes without materially affecting the

terms and conditions of the Promotion. Entrants not complying with all rules are subject to disqualification and an alternate winner will be selected from among all eligible, non-suspect entries received as of the time of such disqualification, as the Sponsor, Illinois Lottery or Administrator determine in their sole discretion. If for any reason the Promotion (or any portion thereof) is not capable of being executed as planned, or in the case of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures or any other causes, that in the opinion of Sponsor, Administrator or the Illinois Lottery, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion (or any portion thereof), Administrator, Sponsor, and the Illinois Lottery reserve the right in their sole discretion to disqualify any suspect entry or entrant and/or to cancel, terminate, modify or suspend the Promotion (or any portion thereof). In the event of any termination, cancellation, or suspension, notice thereof will be posted on the Illinois Lottery website.

**12. APPLICABLE LAWS:** All entrants agree to comply with and abide by all applicable laws, including the Illinois Lottery Law (20 ILCS 1605/1 *et seq.*), administrative rules and regulations, instructions, conditions and final decisions of the Illinois Lottery and all procedures established by the Illinois Lottery and the Administrator for the Promotion. In the event of a conflict between these Official Rules and any summary, representation, or other restatement of rules appearing in any advertisement, point of sale material, tickets or other media, these Official Rules shall govern. In the case of a conflict or contradiction between or among the Illinois Lottery Law, Illinois Lottery administrative rules (11 Ill. Admin. Code Parts 1700 and 1770), and these Official Rules, the Illinois Lottery Law and administrative rules shall control. The Illinois Lottery does not waive sovereign immunity rights provided under law and nothing in these Official Rules shall be interpreted to constitute a waiver of the Illinois Lottery's sovereign immunity rights.

**13. DISPUTE RESOLUTION:** Except where prohibited by law, by entering, Promotion entrants agree that in the event of a dispute concerning the construction, validity, interpretation, or enforceability of these Official Rules, the determination of the Illinois Lottery shall be final and binding. Any entrant who disputes a final decision of the Illinois Lottery may seek review before an Administrative Law Judge pursuant to Section 7.3 of the Illinois Lottery Law. In accordance with the Illinois Lottery's hearing rules (11 Ill. Admin. Code Part 1700), the Director will review the recommendation of the Administrative Law Judge and, if applicable, the Board, and issue a final decision regarding the dispute. Any party adversely affected by a final decision or order of the Director may obtain judicial review as provided by the Illinois Lottery's hearing rules and Administrative Review Law (735 ILCS 5/Article III). All issues and questions concerning the rights and obligations of participant(s) in relation to Sponsor, Administrator, Illinois Lottery, and their agents shall be governed by and construed exclusively in accordance with the laws of the State of Illinois without giving effect to any principles of conflicts of law of any jurisdiction. Entrant agrees that any such action at law or in equity shall be filed only in the state or federal courts located in Chicago, Illinois, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action. EXCEPT WHERE PROHIBITED BY LAW, BY PARTICIPATING IN THIS PROMOTION, EACH ENTRANT AGREES THAT: (A) ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS PROMOTION, OR AWARDING OF THE PRIZES, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; AND (B) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, INCLUDING COSTS

ASSOCIATED WITH PARTICIPATING IN THIS PROMOTION BUT IN NO EVENT ATTORNEYS' FEES; AND (C) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN AWARDS FOR AND HEREBY WAIVES ALL RIGHTS TO CLAIM PUNITIVE, INCIDENTAL, CONSEQUENTIAL, MULTIPLIED OR OTHERWISE INCREASED DAMAGES; AND ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES.
