**Report of Revenues, Prize Disbursements and Other Expenses for the  
Illinois Department of the Lottery  
For the Month Ending August 31, 2015**

The weekly sweeps of Lottery retailers generated \$92,881,268.07 in gross revenues to the State Lottery Fund during the month of August 2015.

The FY'15 transfers to the Common School Fund for the month of August were \$28,962,114 (excluding \$9,654,038, the scheduled transfer for August 26, 2015 which had yet to be recorded by the Comptroller). To date, the Lottery has met its statutory scheduled transfers to the CSF in FY'16.

We will be carrying forward a jackpot reserve balance of \$18.9M into the following month for the Lotto (\$6.0M), Mega Millions (\$74.0M), and Powerball (\$120.0M) jackpots, including reserving the funds (\$10.4) for the Illinois' grand prize funding for the July 25, 2015 \$17.0M Lotto winner.

## **Explanation of Transfers by the Department of the Lottery**

### **Transfers to the Common School Fund**

The Illinois Department of the Lottery requests the Illinois Office of the Comptroller to make weekly transfers to the Common School Fund. Each Wednesday, following the sweeps from the lottery retailers accounts, funds are transferred from the State Lottery Fund to the Common School Fund.

The amount of the weekly transfer is based on the FY'09 actual, weekly transfers adjusted for inflation. The rate of inflation used in calculating transfers to the Common School Fund is defined in administrative rules.

If the cash available in the State Lottery fund does not support the planned weekly transfer amount, a transfer is made at an amount affordable and any shortfall is to be made up in future weekly transfers as funds become available.

In August, the Department made 4 weekly transfers of \$9,654,038, for a monthly total of \$38,616,152 to the Common School Fund. At the end of August, the cash balance in the State Lottery Fund was \$89.2M.

### **Transfer to the Capital Projects Fund**

The Illinois Department of the Lottery requests the Illinois Office of the Comptroller to make one annual transfer to the Capital Projects Fund. On or before June 30 of the fiscal year, the Department estimates the net income available after transfers to Common School Fund and specialty ticket funds.

The transfer is made from the State Lottery Fund to the Capital Projects Fund through a non-appropriated line item.
