## **Explanation of Transfers by the Department of the Lottery**

### **Transfers to the Common School Fund**

The Illinois Department of the Lottery is mandated to make a monthly transfer to the Common School Fund on the last day of each month or shortly thereafter. Currently, the Lottery requests the Illinois Office of the Comptroller to make weekly transfers to the Common School Fund. Each Wednesday, following the sweeps from the lottery retailers accounts, funds are transferred from the State Lottery Fund to the Common School Fund.

The amount transferred during any given month is based on the FY'09 actual monthly transfer for the respective month adjusted for inflation. The monthly amount is then broken down to weekly transfer amounts. The rate of inflation used in calculating transfers to the Common School Fund is defined in administrative rules.

If the cash available in the State Lottery fund does not support the planned weekly transfer amount, a transfer is made at an amount affordable and any shortfall is to be made up in future weekly transfers as funds become available.

In November, the Department made 2 weekly transfers of \$12,613,873 and \$12,613,872 (each) for a monthly total of \$50,455,490 to the Common School Fund. At the end of January, the cash balance in the State Lottery Fund was \$151.7M.

### **Transfer to the Capital Projects Fund**

The Illinois Department of the Lottery requests the Illinois Office of the Comptroller to make one annual transfer to the Capital Projects Fund. On or before June 30 of the fiscal year, the Department estimates the net income available after transfers to Common School Fund and specialty ticket funds.

The transfer is made from the State Lottery Fund to the Capital Projects Fund through a non-appropriated line item.

The weekly sweeps of Lottery retailers generated \$168,531,644.46 in gross revenues to the State Lottery Fund during the month of January 2016.

The FY'16 transfers to the Common School Fund for the month of January were \$63,821,768 (including \$13,366,278, the scheduled transfer for December 30, 2015 that was recorded by the Comptroller in January). To date, the Lottery has met its statutory scheduled transfers to the CSF in FY'16.
